

Re-direct examination. My recollection is that the contusion I found on the back part of the left side of the plaintiff's head was of larger surface than that on the brow. I think the injury on the left hand side of the head was about opposite the injury on the right side of the forehead. In judging the seriousness of the injury, the weapon with which it was given, the history of the injury and the direction of the blow have to be considered. Where hemiplegia ensues--that is caused by a lesion usually on the opposite side of the head from that of the hemiplegia. It is the lesion and not the blow that causes the paralysis. The counterblow is an injury which has been transmitted. A blow may occur on one side of the head, and there may possibly be no abrasion at all. It is only where I find an external fracture that I can locate the side that paralysis must ensue. It is a fact, that paralysis will ensue from injuries that leave very little external mark. If the side of the board was the part which struck the head I should expect possibly simply a contusion. It might be even more than that if the blow came with sufficient force A blow proceeding from a board flying through the air a distance of sixty or seventy feet, starting from a point twenty or twenty-five feet...
